



1. Member States shall provide publishers of press publications with the rights provided for in Article 2 and Article 3(2) of Directive 2001/29/EC so that they may obtain fair and proportionate remuneration for the digital use of their press publications by information society service providers.

2 a. The rights referred to in paragraph 1 shall not extend to mere hyperlinks, which are accompanied by individual words.

Member States shall be free to determine the insubstantial nature of parts of press publications taking into account whether these parts are the expression of the intellectual creation of their authors, or whether these parts are individual words or very short excerpts, or both criteria.

RAT

1 a. The rights referred to in paragraph 1 shall not prevent legitimate private and non-commercial use of press publications by individual users.

(4 a) ‘online content sharing service provider’ means a provider of an information society service one of the main purposes of which is to store and give access to the public to a significant amount of copyright protected works or other protected subject-matter uploaded by its users, which the service optimises and promotes for profit making purposes.

Online content sharing service providers perform an act of communication to the public and therefore are responsible for their content

the Commission and the Members States should organise dialogues between stakeholders to harmonise and to define best practices.

an online content sharing service provider shall not be liable for acts of communication to the public or making available to the public within the meaning of this Article when:


(a) it demonstrates that it has made best efforts to prevent the availability of specific works ... by implementing effective and proportionate measures
